THE 2/- "BELL" DESIGN OF VICTORIA, 1880-1885

This exhibit provides a study of the various printings of this stamp, both the original printings of 1881-1884, and the 'STAMP DUTY' overprints of 1885, including proofs, SPECIMEN overprints, and use for both postal and fiscal purposes. The use of a single printing plate is demonstrated, and a sample of the major plate flaws is presented, as well as a study of the setting of the 'STAMP DUTY' overprint. Much of the information presented is based on the personal research of the exhibitor.

The need for two new denominations (½d and 9d) and to replace several existing plates led to a series of new designs being commissioned in the early 1870s from William Bell, a local Melbourne engraver, who also engraved the dies. A 2/denomination was ordered to replace the combined Woodblock/Electrotype plate which had been in use since 1854, and this die was engraved i3n 1874. Despite its availability, for reasons unknown printings of the old 2/- design continued up to 1880. The 2/- Bell Design was finally issued in early 1881, and was the last of the new designs to appear.

The stamp was rendered obsolete by the 1883 Post Office Act, which authorised for postal use the existing adhesive series inscribed 'STAMP STATUTE' and 'STAMP DUTY'. At the same time, existing postage issues were authorised for fiscal use. All future issues were to be inscribed 'STAMP DUTY'. A large stock of the 2/- Bell Design remained, and it was decided that these should be overprinted 'STAMP DUTY'. This was done early in 1885.

The large proportion of the stamps were overprinted 'STAMP DUTY' and the earlier issues are relatively scarce, especially mint or in multiples; use on cover is rare. Post-1884 fiscal use represents approximately 85% of all surviving material.

The archival records are largely silent regarding the order for a 2/- die. It is apparent, however, that the die was ordered late in 1874, following the production of the dies for the ½d, 2d and 9d Bell Designs.

It is assumed that the printing plate was then manufactured at this time. However, use of the 2/- Woodblock/ Electrotype Design which had been in use since 1854 continued, with fresh printings being made up to 1881. No reason is apparent for this. The 2/- Bell Design was finally issued in early 1881.

All recorded die proofs are in an unfinished state, showing the top right, lower left and lower right denominations yet to be engraved, and have come from the estate and descendants of the engraver, William Bell. It is understood that one of the terms of the contract for engraving was that the die was to be completed at the G.P.O. Melbourne, to ensure that no illicit use could be made of the completed die.

THE PRINTINGS

Three printings were made of the 2/- Bell Design. All were printed on Watermark V over Crown (V2) green glazed paper and comb-perforated $12\frac{1}{2}$.



Printing 1 November 1880

By 1880 overseas postal rates had fallen to levels at which they remained until U.P.U. membership (the U.K. rate was 6d for a half ounce letter), so use of the 2/- stamp was restricted to overweight articles.

REGISTERED MAIL TO IRELAND



Pair used with 4d Laureated Design cancelled '1' obliterator in thin bars on 27 September 1881 registered cover from Melbourne to Dublin, Ireland. Carried by P. & O. steamer via Brindisi with London transit datestamp and Dubin arrival on reverse (9 November 1881).

Prepaid for 4 ounce letter at 6d per half ounce plus 4d registration fee.

Five covers bearing the 2/- Bell stamp are recorded, this being the only multiple.

Printing 1 November 1880 Deep Blue on Green Comb Perf. 121/2

REGISTERED MAIL TO ITALY



Used with 1d and 1/- Bell and 2d Naish Designs cancelled '1' obliterator in thin bars on November 1885 registered cover from Melbourne to Rome, Italy. Carried by Orient Line 'John Elder' to Naples, with Rome arrival datestamp (9 12 83).

Prepaid for 2½ ounce letter at 7d per half ounce plus 4d registration fee.

Five covers bearing the 2/- Bell stamp are recorded.

Printing 2 April 1883 Light Blue on Green Comb Perf. 12½ 35,040 stamps

A proportion of this printing is found with watermark sideways. These must have arisen die to cutting the 240-on sheets of watermarked paper, with some sheets turned 90° prior to printing. Approximately 20% of the printing shows watermark sideways.

The third printing comprised 266,400 stamps, however of this quantity 222,000 were subsequently overprinted "STAMP DUTY". The issue without overprint was therefore 44,400. As in the previous printing a proportion of this printing is found with watermark sideways. In this case, however, the sideways variety comprises about 90% of the printing.

THE 1891 REPRINT





12,000 stamps printed from a new plate to provide obsolete stamps for distribution to the U.P.U. (overprinted REPRINT). The cancelled-to-order stamps (dated JE 2 02) are scarcer but their purpose is not known.

THE 1885 "STAMP DUTY" OVERPRINT

The 1883 Post Office Act, which came into operation on 1st January 1884, authorized the interchangeable use of Stamp Statute, Stamp Duty and Postage adhesive stamps for both postal and duty purposes. All future issues were to be inscribed 'STAMP DUTY'. The existing postage stamps continued in use throughout 1884, but by the end of that year considerable stocks were still held of the 3d, 4d, 1/- and 2/- denominations. It was decided that these should be overprinted 'STAMP DUTY'.

The 2/- Bell issue was sent for overprinting on 3 March 1885, and the stamp was probably issued later in the same month. Both upright and sideways watermarks are found. Only about 5% of the printing is found postally used.

All printings were made from a single 120-on copper electrotype plate in 10 rows of 12. The plate was coated, probably with nickel, to provide a harder surface for printing and lessen wear of the plate. This nickel coating was quite poorly applied, and there are imperfections caused by the uneven application of the coating, especially affecting the frames of the stamps.

These flaws are so numerous, and constant, that it has been possible to isolate and identify all 120 units making up the plate. However, the lack of multiples means that the actual reconstruction of the plate cannot be completed.

THE 'STAMP DUTY' OVERPRINT FORME

A casual examination of a quantity of the 'STAMP DUTY' overprints shows that the positions of 'STAMP' and 'DUTY' to each other varies considerably.

However, if one groups all the left vertical column and right vertical column stamps (as indicated by 'line' watermarks), it will be seen that the positioning of 'STAMP DUTY' is constant, and that other individual flaws on the letters are found.

This indicates that the overprint was set up as a horizontal row of 12, which was then duplicated ten times by electrotypy or stereotypy and clamped together to provide a 120-on overprint forme.




